4. Course Objectives and Format

The DAN Department of Management and Organizational Studies as a whole draws upon an evidence-based management approach. Evidence-based management is the systematic process of gathering evidence from multiple sources, critically appraising the evidence, and using that evidence in making and evaluating management decisions to improve organizational performance.

4.1 Course objectives

Building on MOS 3360 Intermediate Accounting I, students evaluate the appropriate treatment of accounting transactions associated with liabilities and shareholders' equity, analyze accounting

changes and errors, prepare financial statements, and evaluate other measurement and disclosure issues in financial reporting.

4.2 Course format

Class Time: Classes will be conducted synchronously via Zoom at the scheduled time. Attendance is required. The scheduled class time will be used by the course instructor in a variety of ways to support your online learning. Class time may consist of lectures, group work, problem solving, and discussion. Class preparation is expected.

Practice Problems: Each week students will have assigned questions to apply what they have learned through the lectures and chapter readings. To perform well in this course, students must spend time completing accounting problems and reviewing the answers to check understanding.

Self-Study Problems: Self-study problems will provide the student with the opportunity to further practice the course material.

Solutions: Official solutions to the assigned and self-study questions will be made available on the course OWL site after the relevant material is covered by all sections. It is expected that students will attempt the question prior to reviewing the solution.

Discussion Forum: For course related questions, students should first refer back to the course materials (textbook and lecture notes). If the student is not able to resolve their question, then the next step is to post their question in the discussion forum. It is encouraged students review the forum on a regular basis to enhance their learning and address other students' questions.

WileyPLUS Homework Assignments: Students will complete homework assignments for each chapter to check their understanding of the course material. It is highly recommended these are completed after the assigned problems have been attempted and debriefed. These assignments will be submitted and graded, and contribute to the student's final grade.

Assignment and Examinations: The assignment and examinations will test the student's comprehension of both the technical and conceptual aspects of the course.

Mastery of intermediate accounting concepts will require considerable time reading the textbook and attempting assigned accounting problems. To perform well in this course, you must spend time completing accounting problems and checking the answers to check your understanding. To maximize your learning, you should make an honest attempt at the accounting problem before reviewing the solution. This is not a course to register in if you are seeking an easy credit. For many students, this course is a difficult one. The difficulty arises from a challenging subject matter as well as failing to devote enough time to the course content, including preparing for class, working through accounting problems, and completing the weekly assignments. You will find that there is likely to be a direct correlation between the number of accounting problems you prepare, the adequacy of your debrief of those problems, your attendance in class, your completion of the weekly assignments and your course grade.

5. Learning Outcomes

Upon successful completion of this course students will be able to:

- 1. Assess the accounting issues associated with the liabilities and shareholders' equity side of the Statement of Financial Position in order to determine the most appropriate approach to the recognition, measurement, presentation, and disclosure of these issues.
- 2. Account for income taxes, employee future benefits and leases.
- 3. Prepare two financial statements the Statement of Shareholders' Equity and the Cash Flow Statement and communicate the results using the appropriate format.
- 4. Apply present value concepts to solve accounting problems.
- 5. Account for changes in accounting policy, estimates, and errors.

6. Apply full disclosure in financial reporting, specifically for related-party transactions and subsequent events.

Students are **REQUIRED TO COMPLETE ALL COMPONENTS** of this course to receive a passing grade. There are no exceptions to this. Extra assignments to improve grades **will NOT** be allowed. **Students MUST PASS both the midterm and final exams in order to pass the course.**

Grades <u>will not be adjusted</u> on the basis of need. It is important to monitor your performance in the course. Remember: You are responsible for your grades in this course.

The DAN Department has a grade policy which states that for courses in the 3000 range, the class average must fall between 70% and 77% for all sections of a course taught by the same instructor. In very exceptional circumstances only, class averages outside this range may be approved by the Undergraduate Chair or Chair. Class averages are not grounds for appeal.

6.1 WileyPLUS Homework Assignments

The WileyPLUS homework assignments are an integral part of the learning process in this course, and are intended to supplement the class discussion, chapter readings, and assigned practice problems. Homework assignments are to be completed **after** reviewing the chapter, attending the class, and completing the assigned practice questions to enhance the student's understanding of the course content. The deadline for each homework assignment is available in WileyPLUS and on the course OWL site.

6.2 Assignment

There will be one hand in assignment required for this course. The assignment will require students to research accounting issues and draw on the student's critical thinking, analytical, and writing skills. It is due no later than 9:00 am EST on Thursday, February 11, 2021.

Students have the option to work individually or in pairs to complete the assignment. Beware of working in pairs and using material provided by other students without proper referencing - this will be considered cheating. Plagiarism is a serious academic offence that can result in a penalty as severe as expulsion from the University. Whenever you take an idea or a passage from another author, you must acknowledge your source by using quotation marks where appropriate, and by proper referencing such as footnotes and citations.

Assignments must be submitted using Word through the Assignment tab on the course OWL site so that Turn-It-In may be used to detect any plagiarism that may have occurred.

Any assignment received after the due date will result in a grade of zero (0).

6.3 Examinations

Exams may consist of a combination of multiple choice, short-answer questions, long-answer problems, and written responses. All exams are **closed book examinations**. Refer to Section 9 for Exam Policies.

Students are responsible for material covered in class as well as the assigned chapters in the text. Exams will not be returned to students but may be discussed with the instructor.

Tests and examinations in this course will be conducted using Zoom and/or the remote proctoring service, Proctortrack.

When Zoom is used for exam invigilation, you will be required to keep your camera on for the entire session, hold up your student card for identification purposes, and share your screen with the instructor or proctor if asked to do so at any time during the exam.

Proctortrack will require you to provide personal information (including some biometric data). By taking this course, you are consenting to the use of this software. More information about remote proctoring is available in the Online Proctoring Guidelines at the following link:

This course must use proctored assessments to ensure continued accreditation by CPA Ontario. Because the size of the class precludes in-person delivery, assessments must proceed online, which in addition supports the ability of students to take the course from a remote location. Online proctoring assures students that they can write assessments on equal terms with their classmates and signals to prospective employers, graduate supervisors, and professional schools that, despite the COVID-19 pandemic, Western has endeavoured to maintain the high standards that are at the core of our degrees.

6.4 Professionalism

Professionalism will be assessed on a weekly basis during synchronous Zoom classes according to the following rubric:

<u>Level</u>	<u>Description</u> .
0	Student is late for a synchronous class, absent from class or attends class and does not demonstrate <u>professionalism</u> .
1	Student demonstrates professionalism , but does not engage in group work or contribute to the discussion.
2	Student demonstrates professionalism and the student engages in group work, contributes to the discussion by asking/ answering questions that are primarily factual in nature.
2.5	Student demonstrates professionalism , engages in group work, and contributes to discussions and adds value to the discussion.

Professionalism in a synchronous class is demonstrated in the following ways:

- 1. Students must use their UWO credentials to be permitted to access the class.
- 2. Arrive to class on time (by 29 minutes after the hour) and remain in class for the full duration.

- 3. Use a computer and/or laptop if possible (as opposed to a cell phone or tablet).
- 4. Ensure that you are in a private location to minimize distractions.
- 5. Ensure your full name (or nickname, upon prior communication with the instructor) is displayed.
- 6. Keep your video turned on for the full duration of the class, and be prepared to turn your video camera off at the instructor's request if the internet connection becomes unstable.
- 7. Mute your microphone for the entire class until you are invited to speak.
- 8. Be prepared to share your screen during group work and/or class discussions.

Class participation and engagement is an integral part of the learning experience in this course. Therefore, it is expected that every student will be prepared for class and be a willing participant in discussions. If you wish to speak, use the "raise hand" function and wait for the instructor to acknowledge you before beginning your comment or question. Voluntary class participation is expected; however, students may also be cold-called to discuss assigned material.

Professionalim marks can make a significant difference in achieveing a student's goal for their final course grade. **Professionalism marks must be earned.**

General considerations of "netiquette":

- Keep in mind the different cultural and linguistic backgrounds of the students in the course.
- Be courteous toward the instructor, your colleagues, and authors whose work you may be discussing.

9. Exam Policies

There will be a zero-tolerance policy for cheating on examinations. Cheating is an academic offence. Students that cheat will receive a zero (0%) on the exam and may face further academic penalties such as receiving a zero (0%) in the course, suspension from the University, or expulsion from the University.

- All exams are closed book. NO notes of any kind are permitted. Students are not permitted to
 access any materials to assist in completing exams. This includes both physical and electronic
 resources. Students are not permitted to access the textbook, slides, or notes of any kind.
 Doing so will be considered cheating.
- Students are not permitted to access any individuals to assist in completing exams. Students
 must write the exam on their own, in their own words. Students may not discuss or share the
 contents of the exam or their response with anyone else. Doing so will be considered
 cheating.
- 3. Students are not permitted to speak with anyone during an exam.
- 4. Video and microphone (on mute) must be turned on to write the exam and remain on for the duration of the exam. The camera should be set up in such a way that the proctor can see all of the student.
- 5. The use of a non-programmable calculator is permitted. Cell phones cannot be used as calculators.
- 6. Dictionaries are not permitted during exams.
- 7. Electronic devices of any kind, not including the laptop or computer the student uses to write the exam, are NOT permitted during exams. This includes tablets, cell phones, smart watches, pagers, music players, and programmable calculators.
- 8. Students are not permitted to print the exam.
- 9. One blank sheet of paper will be permitted. The proctor will ask the student to show both sides of the paper prior to commencing the exam.
- 10. Food and drinks are permitted.
- 11. Pencil cases are NOT allowed at the desk.
- 12. Hats, ear buds, and headphones will NOT be permitted.
- 13. Students are not permitted to leave the room during the exam.
- 14. All applications, webpages, browsers, programs and materials should be closed on the student's computer prior to and during the exam. The only webpage permitted to be open is the course OWL site.

There will be internal controls built into exams to identify and detect cheating. In addition, response files will be run through Turnitin.com to check for academic honesty and integrity.

If a student fails to follow the exam policies for any reason, it will result in an automatic fail on the exam. Western's code of conduct will be enforced. Students are referred to the university policy on scholastic offences.

10. E-Mail Policies

10.1 UWO.CA Email Addresses Only

10.2 Subject Line Must Include Course and Section Number

The subject line of emails must contain the name or number of the course, and the section number in which the student is enrolled. The instructor teaches different courses and sections and cannot properly respond to questions if he does not know which course or section you are enrolled in.

11. Attendance

It is expected that students will attend all classes online. The course instructor will not provide access to the lecture after it has been presented. Students are encouraged to obtain missed lecture notes from a fellow student.

11.1 Short Absences.

If a student misses a class due to minor illness or other problems, it is the student's responsibility to check the course outline for information regarding attendance requirements and to make sure they are not missing a test or exam. Students are responsible for covering any readings and arrange to borrow the missed lectures notes from a classmate.

11.2 Extended Absences.

If a student is absent for more than approximately two weeks, has not engaged sufficiently in the course, or gets too far behind to catch up, the student should consider reducing their workload by dropping one or more courses. The <u>Academic Counsellors</u> can help students to consider the

alternatives. At the student's request, they can also keep instructors informed about student difficulties.

12. Grade Fairness

Fairness requires that all students be treated equally and be evaluated using the criteria set out in this course outline. The evaluation criteria are based on actual achievement and not on how hard a student has tried.

Claims by students of an excellent academic history, good attendance record, need to obtain or maintain a scholarship, desire to be admitted to Ivey or graduate school, or other personal issues, cannot be used to justify a higher grade in the course or a reweighting of course components. There is no extra work or assignments available for extra credit or to "make up" for a course component that was missed or performed poorly.

Midterm exam grades will be posted on OWL once the grades are available. Final exam grades and final course grades are not posted on OWL and are available once they have been posted by the Registrar under "Academic Summary" at the <u>Student Centre</u> website.

14.2 Make Up Examinations

The student must write a make-up exam if the regularly scheduled exam is missed for reasons for which adequate documentation is received by the instructor (this documentation must be supplied by the <u>Academic Counseling office</u>).

The format of the make-up assessment may differ from the original assessment.

The date and time of make-up examinations will be set by the course instructor, who will communicate the date to the student.

If a student is unable to meet the scheduled make-up exam as agreed, then the student is responsible for obtaining new accommodations from Academic Counselling, the student will receive a SPC as their grade for this course, and will write the make-up exam the next time the course is offered.

15. University Policy on Cheating and Academic Misconduct

Students are responsible for understanding the nature of and avoiding the occurrence of plagiarism and other academic offenses. Students are urged to read the section on Scholastic Offenses in the <u>Academic Calendar</u>. Note that such offenses include plagiarism, cheating on an examination, submitting false or fraudulent assignments or credentials, impersonating a candidate, or submitting for credit in any course without the knowledge and approval of the instructor to whom it is submitted, any academic work for which credit has previously been obtained or is being sought in another course in the University or elsewhere. If you are in doubt about whether what you are

doing is inappropriate, consult your instructor. A claim that "you didn't know it was wrong" will not be accepted as an excuse.

Cheating on exams will not be tolerated; students are referred to the university policy on scholastic offenses. Looking at the test of another student, allowing another student to view your exam, or obtaining information about a test in advance are all examples of cheating.

Students found cheating will receive a zero (0%) on that exam. A number of safeguards will be employed to discourage cheating. For example, students may be asked to do a room scan, share their sreen, show the contents on their workspace, refrain from using the washroom during the exam, remove baseball caps, etc. This is not meant as a personal affront nor as an accusation of cheating, rather as vigilant attempts at proctoring.

The penalties for a student guilty of a scholastic offense include refusal of a passing grade in the assignment, refusal of a passing grade in the course, suspension from the University, and expulsion from the University.

16. Procedures For Appealing Academic Evaluations

- 1. In the first instance, all appeals of a grade must be made to the course instructor (informal consultation).
- 2. If the student is not satisfied with the decision of the course instructor, a written appeal must be sent to the Undergraduate Chair: Student Affairs of the Department of Management and Organizational Studies.
- 3. If the response of the Undergraduate Chair is considered unsatisfactory to the student, he/she may then appeal to the Dean of the Faculty in which the course of program was taken.
- 4. Only after receiving a final decision from the Dean may a student appeal to the Senate Review Board Academic. A Guide to Appeals is available from the Ombudsperson's Office.
